Impact:

We have changed the courses required in the Accounting and Management core and in the Management concentrations. These changes will allow us to offer some courses less frequently than they are currently offered. We have analyzed the impact and have determined that significant staffing resources will not be affected.

Rationale:

MGMT 220 has been reinstated as a requirement for Accounting and Management. MGMT 220 provides students with a basic understanding of Management and how the core management areas relate to one another. The Department has identified courses that do not require this level of understanding and have made them available to the general student body. MGMT 352 is no longer required and is being removed as a prerequisite for MGMT 453.
