APC Document 50: Change the major and minor requirements for Religious Studies

Effective Date: Fall 2015

- 1. **Delete:** On page 257, under the entry for **Major in Religious Studies:**
 - I. Required courses in the major—at least 35 hours, including: RELS 200, 280, 312, 313, 398, 490; one course from those listed under Religions of the West; one course from those listed under Religions of Asia; one course from those listed under Interdisciplinary Approaches to Religion; and 6 additional hours of electives chosen from other RELS courses or courses in the above categories. At least 18 of the required 35 hours must be at the 300-400 level. The department chair may approve additional courses when the subject matter is appropriate to Religious Studies.
 - II. Required courses outside the major—None.
 - III. Other departmental requirements—Completion of RELS 398 with a grade of C or better demonstrates major competency. Completion of RELS 490 with a grade of C or better demonstrates oral competency.

Add: On page 257, in place of deleted entry:

- I. Required courses in the major —at least 36 hours, including: RELS 200, 398, 492; one course from those listed under Religion and Western Culture; one course from those listed under Religions of Asia and Africa; one course from those listed under Interdisciplinary Approaches to Religion; and 12 hours of electives chosen from other RELS courses or from the list of approved courses. 20 of the required 36 hours must be at the 300-400 level. The department chair may approve additional courses when the subject matter is appropriate to Religious Studies.
- II. Required courses outside the major—None.

Impact statement: These changes will have no negative impact on the department or the university and will not require the addition of any new faculty or other resources. The department will be able to deliver its curriculum while continuing to support LAC requirements.

Rationale: The Department of Religious Studies is revising its curriculum for the following reasons: (1) to adopt the 4 credit hour model as recommended by the Curriculum Review Task Force (CRTF) and necessitated in part by the fact that many departments with which we share crosslisted courses have already adopted such a model; (2) to incorporate the new requirements of the Liberal Arts Core Program, which makes evaluation of information literacy and discipline-specific writing the responsibility of departments; and (3) to streamline our course offerings in an effort to increase sustainability; and (4) to incorporate new courses and a new configuration of major and minor requirements that reflect recent faculty appointments.

Although the number of credit hours required of majors has been increased by one (from 35 to 36 hours), the number of specified courses required for the major has been reduced, thus giving students more options in course choices. RELS 200: Introduction to the Study of Religion will remain the gateway course, and we will continue to require two capstone courses (RELS 398 and RELS 492) for all majors. Since these courses focus on theory, methodology, and application, they offer appropriate foundations and skills for the academic study of religion. The remainder of the courses required for the major offer students a great deal of flexibility, although the arrangement by distribution requirements ensures that students are exposed to a breadth of religious traditions. Such flexibility is in keeping with the spirit of the CRTF recommendation that students be allowed more opportunities to explore "elective" courses. The tradition of the department – supported by the inherently multidisciplinary nature of the study of religion – to allow students the option of taking approved elective courses outside of the department for RELS credit offers a range of choices to majors in Religious Studies that underscores the objectives of a liberal arts education. We are also fortunate that two of our courses (RELS 387 and 389) are regularly taught by faculty outside of the department, and that five additional courses are crosslisted with other departments and also taught by outside faculty, so in any given semester 4-12 additional RELS credit hours are offered to students beyond those taught by departmental faculty.

Certification of major and oral competencies has not changed (through completion of RELS 398 and the Senior Seminar respectively with a C of better). Similarly, satisfying the requirement for information literacy will continue to be met by the successful completion of RELS 398. Writing competency will be demonstrated by completion of RELS 492 with a grade of C or better, although most 300-400 level courses will continue to require significant writing.

To ensure that student learning outcomes are met in knowledge of the major, critical thinking, information literacy, written communication, and oral communication, certain courses designated as addressing these skills will integrate content-oriented classroom lectures and discussions with associated "skills labs" to be offered by faculty. This table presents a model pathway toward graduation by Religious Studies majors under the 4 credit hour curriculum:

Faculty load: The departmental faculty has been heavily invested in offering courses that met various requirements for the ILS Program; this will not change with the conversion to a four credit hour curriculum. Assuming that the faculty remains at its current strength of three full-time members teaching 12 credit hours each semester (with a one course release each year for the chair), we will be able to deliver the departmental curriculum each year as illustrated:

The "additional credit hours" will be used for offering courses outside of the department (HUM, HON, LA 178) or for other RELS electives, including special topics courses. Note that RELS 280, which will be offered every fall semester, serves the LAC Program as both a DI and an ARTS course. Note that responsibility for offering our capstone courses (RELS 398 and 492) circulates among the faculty, with RELS 398 offered in the spring semester and at least one section of RELS 492 offered the following fall by the same instructor; the above chart offers only a single year's "snapshot" of the curriculum. Potentially, each member of the departmental faculty could offer two courses outside of the department every year in support of the LAC and other programs.

2. Delete: On page 258, under the entry for **Minor in Religious Studies:**

18 hours distributed as follows: RELS 200 and 280; at least one course from those listed under Religions of the West; at least one course from those listed under Interdisciplinary Approaches to Religion; and 6 additional hours of electives chosen from among other RELS courses or the list of approved elective courses. At least 9 hours must be at the 300-400 level. The department chair may approve additional courses when the subject matter is appropriate to Religious Studies.

Add: On page 258, in place of deleted entry:

At least 20 hours distributed as follows: RELS 200; one course from those listed under Religion and Western Culture; one course from those listed under Religions of Asia and Africa; one course from those listed under Interdisciplinary Approaches to Religion; and at least one course chosen from RELS courses or from the list of approved courses. No more than 8 hours of approved electives may come from a single department outside of Religious Studies, and at least 12 hours must be at the 300-400 level. The department chair may approve additional courses when the subject matter is appropriate to Religious Studies.

Impact statement: These changes will have no negative impact on the department or the university and will not require the addition of any new faculty or other resources.

Rationale: This change to the minor simply reflects the changes that are necessitated by the conversion from a 3 to 4 credit hour curriculum, although, like the revised major, it is designed to offer students an array of course choices while ensuring some breadth in terms of content matter.
