**Impact:** The expected impact on resources and staffing of the Department of Sociology and Anthropology is minimal. The impact for students is increased transparency about when courses will be available, and fewer chances of promising a course that proves to be undeliverable due to changes in staffing resources. The more flexible course offering patterns accommodate unforeseen leaves and course releases, as well as any additional teaching needs external to the department.

For SOC 200, 210, and 220, one of these must be offered each semester for teacher licensure, but we need staffing flexibility that allows us to not promise one specific course. Even if we listed the offering on these courses as "every third semester", that wouldn't always be accurate because which course is offered depends on instructor availability. Changing the offering to "see department chair" seemed the least problematic option.

**Rationale:** Due to recent retirements, PDLs, FMLAs, and other release time, our department is not always able to anticipate elective offerings with accuracy. We have a clear offering pattern for required courses (e.g. SOC 338 changing from Fall to both Fall and Spring), but electives offerings can vary without affecting completion of the major. Where we have greater certainty, we have retained more specific offering patterns.
